



Registration Information – Summer 2020

WHAT TO BRING TO CAMP

- Clothes for warm, cold, wet, and dry weather (Weather conditions are unpredictable!)
- Sunscreen, insect repellent and hat
- Sleeping bag & pillow
- Blanket (for outdoor use)
- Running shoes (and/or shoes that can get dirty/muddy)
- Sandals
- Appropriate swimwear
- Bible
- Toiletries
- OHIP Card
- One 'nice' outfit (optional – Traditionally dinner on Friday night is a 'banquet' and some campers enjoy getting a little bit dressed up)

Please note certain items are not permitted at camp (i.e. cell phones, mp3 players, etc). Such items may be held in the office for safekeeping while your child is at camp.

Please note that all medications must be in their ORIGINAL containers, CLEARLY labelled with dosage information, and with the NAME of the recipient. Medications will ONLY be dispensed as indicated on the label to the person named on the label.

Parents/Guardians must check their child's head for lice prior to arriving at camp. Campers who are found to have head lice upon arrival at camp will not be allowed to remain unless and until they have been treated and are found to have no evidence of lice or nits. Please contact the Camp Manager if you have any questions regarding this policy.

ARRIVAL/DEPARTURE TIMES

Registration - **Sunday at 3pm**. Please do NOT arrive early. Upon arrival, you will be asked to provide the name of the person who will be picking your child up at the end of the week.

Camp ends - **Saturday at 11:30 am**. Light refreshments will be provided for those arriving to pick up campers. You will have an opportunity to speak with your child's cabin leader and program directors. Campers are expected to depart by 12:00 pm.

Weekend camps begin on Friday after supper (7:00 pm) and end Sunday after lunch (2:00 pm).

Please help us ensure the safety of our campers, staff, and neighbours by adhering to the posted speed limit (30 km/h) on Glendale Rd on your arrival to, and departure from, camp.

WAIVERS and CONDITIONS OF ENROLLMENT

Camp Hermosa Inc. reserves the right to dismiss a camper, who, in the opinion of management, has become a hazard to the safety and rights of others or who appears to have rejected the reasonable medical/emotional/behavioural conditions on the registration form.

For the safety of campers, conditions of custody, if applicable, will be fully communicated, in writing, to the camp, including a photocopy of any court order referring to visitation rights. These documents will be presented to the Resource Worker or Manager upon registration at camp.
